### **Request under the Official Information Act 1982**

Thank you for your email of 24 October 2024, requesting the following information from Te Pūkenga – New Zealand Institute of Skills and Technology (Te Pūkenga):

- *Please detail the total sum paid to placement providers for clinical placement fees for the academic years 2022, 2023 and within the 2024 budget.*
- *Please provide the response*
  - *Total dollars paid each year*
  - *Break down per provider type*
    - *DHB*
    - *Aged care*
    - *Private practice*
    - *NGO's*
    - *Others*

On 18 November we wrote to you advising of an extension to the timeframe for making a decision on your request to 17 December 2024. This letter provides a formal decision on your request under the Official Information Act 1982 (OIA).

### **The decision**

Information collated from 13 Te Pūkenga business division schools of nursing is attached as a series of tables at **Appendix One**.

As described in previous letters to you, we have endeavoured to ensure the information provided is accurate. However, there may be some inconsistencies due to the different ways in which information is defined, collected and reported across the individual business divisions.

In order for us to grant your request and make it administratively achievable, whilst taking into account your previous request history regarding nursing and clinical placements, we have interpreted your questions to be about nursing only, including Bachelor of Nursing, New Zealand Diploma in Enrolled Nursing and Competence Assessment Programmes.

To retain the integrity of the information provided across the network, we have presented the information largely as it was received from the divisions with a few small additional points to assist you. Where business divisions have supplied specific budget information for 2024 this has been noted.
