Request under the Official Information Act 1982

Thank you for your email of 22 November 2024, requesting information from Te Pūkenga – New Zealand Institute of Skills and Technology (Te Pūkenga).

Further to our letter dated 15 November, in response to your recent request for information (reference TP240124), you have requested the following:

Can you now please provide a breakdown of the ethnicity recorded for the domestic and international enrolments in each Te Pūkenga entity and nursing program (EN, RN [sic] and Graduate Entry Nursing).

- For domestic enrolments please report numbers recorded for each ethnicity inclusive of Māori, Non-Māori, Pasifika, NZ Pakeha and any other reported ethnic identify [sic] including Asian, Filipino and or ethnicity
- For international enrolments please reported [sic] numbers recorded for each ethnicity/country of origin

This letter provides a formal decision on your request under the Official Information Act 1982 (OIA).

The decision

Information is provided as two tables at **Appendix One**. The data is a repeat of that extracted in response to your previous request, reference TP240124, again providing ākonga (student) enrolments for the 2024 year as at 4 October 2024. This time by nursing qualification, year of study, domestic ākonga ethnicity, and international ākonga country of citizenship.

Please note ethnicity is self-identified. Domestic ākonga are able to identify more than one at the time of enrolment and therefore may be counted more than once in the data.

In many cases, particularly for the international ākonga, providing the exact count yields results of less than four ākonga. Where this is the case, we have withheld the exact numbers with reliance on section 9(2)(a) of the OIA, to protect the privacy of natural persons. In table two for international ākonga, countries are either provided within the table or as a list below the table. We do not believe the need to withhold this information is outweighed by the public interest in its release.

As per our response to your request reference TP240124, please note that our definition of 'domestic ākonga' includes New Zealand citizens, Australian citizens, New Zealand residents, and any other ākonga eligible for Tertiary Education Commission funding. Please refer to our letter of 15 November for the list of Te Pūkenga nursing programme qualifications (by type, code and title) to which this data applies.

You have the right to make a complaint to the Ombudsman under section 28(3) of the OIA if you are not happy with this response. Information about how to do this is available at <u>www.ombudsman.parliament.nz</u> or by calling 0800 802 602.

We may publish our OIA responses and the information contained in our reply to you on our website. Before publishing we will remove any personal or identifiable information.
